TestInsight Online Privacy Notice

TestInsight is committed to respecting your privacy. Our personal information handling practices are outlined below and in supplemental notices at the point of collection.

Collection of your Personal Information

TestInsight does not collect any personal information such as your name, address, email address. We will explain why we need to collect this information when we ask you for it.

Use of Your Personal Information
